This is the common CSA and UL standard for *Hand-Held Motor-Operated Electric Tools – Safety – Part 2-21: Particular Requirements For Drain Cleaners*. It is the first edition of CAN/CSA-C22.2 No. 60745-2-21 and the first edition of UL 60745-2-21. This standard is an adoption of IEC 60745-2-21, first edition.

This Standard CAN/CSA-C22.2 No. 60745-2-21/UL 60745-2-21, first edition, supersedes:

- a) the first edition of CAN/CSA-C22.2 No. 745-2-35/UL 745-2-35 published in 1995; and
- b) CAN/CSA-C22.2 No. 745-4-35/UL 745-4-35, published in 1995 (requirements for battery tools and battery packs are now incorporated into the requirements of CAN/CSA-C22.2 No. 60745-2-21, first edition, and UL 60745-2-21, first edition).

The standard number has been aligned to correspond with the equivalent IEC 60745-2-21 standard.

This common standard was prepared by the Canadian Standards Association (CSA) and Underwriters Laboratories Inc. (UL).

This standard was reviewed by the CSA Subcommittee on Safety of Hand-Held Motor-Operated Electric Tools, under the jurisdiction of the CSA Technical Committee on Consumer and Commercial Products and the CSA Strategic Steering Committee on Requirements for Electrical Safety, and has been formally approved by the CSA Technical Committee.
